Coloring Contest Terms & Conditions

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The Sturgeon Spectacular – Really BIG Fish Kids Free Coloring Contest ("Contest") will be held from 12:00 a.m. Central Time ("CT"), February 1, 2016 ("Contest Start Date"), to 11:59 a.m. CT, February 12, 2016 ("Contest Period"). Contest is sponsored by the Fond du Lac County Historical Society (the "Sponsor") who is solely responsible for all aspects of this Contest.

2. ELIGIBILITY. The Contest is open to children age 4 to 12 years old who are legal residents of the United States of America. Sponsor's employees and their immediate families are not eligible to participate or claim a prize. Void where prohibited or restricted by law. *By entering you represent that you have all necessary rights to grant a license to the Sponsor to publish and to reuse your entry for any purpose without compensation. All entries must be received by 11:59 a.m. CT, February 12, 2016. All entries become the exclusive property of the Sponsor and will not be returned. No mechanically reproduced entries will be accepted.

4. INTERNET LIMITATIONS OF LIABILITY. If for any reason this Contest is not capable of running as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Contest in whole or in part, at any time, without notice and award the prizes using all non-suspect eligible entries received as of this termination date. The winner will be disqualified and an alternate winner will be selected if a selected winner fails to comply with these rules; cannot be contacted; is ineligible; fails to claim a prize in the stated time period as required, or if the prize notification or prize is returned as undeliverable. Acceptance of a prize constitutes permission to use the winners' names, likenesses and statements for promotional and publicity purposes without additional compensation or limitation unless prohibited by law. All decisions of the Sponsor regarding the selection of winners, notification and substitution of winners in accordance with these Official Rules shall be binding and final.
